In this newsletter you will find information on the annual district vote. Residents are asked to vote on two items: the 2019-20 District budget and two of three residents running for seats on the Board of Education. Our polling place is once again at the St. Paul Blvd. Fire Department, just down the street from the high school.

The budget includes \$100,000 for a Capital Exclusion Project (CEP) to replace interior doors at Irondequoit High School that will improve the security and safety of the building for our students and staff. Approximately 30 classroom doors will be replaced. We will receive more than \$80,000 back in 2020-21 in state building aid.

### Proposed 2019-20 District Budget: \$74,368,265

#### Budget objectives:

- Adjust for enrollment and balancing class sizes to support Tier 1 instruction and planning.
- Continue to increase our sophistication with Response to Intervention (RtI), especially as it relates to K-3 mathematics instruction.
- Prepare for increased technology integration in the classrooms.
- Maintain a sustainable 3 to 5 year financial plan while staying within the Tax Levy Cap.



Following our launch of 1:1 computers at Dake Junior High School in 2017-18, the District added computers for middle school students in Grades 4-6 at Rogers and Iroquois along with Irondequoit High School. That means laptops for Grades 4-12. More computers will be purchased through BOCES generating a 75% state aid reimbursement.

The proposed tax levy increase is 2.83%, which meets our tax levy cap. Because the proposed budget falls within our tax levy cap, it requires a simple majority for passage.

### What if the budget is not approved by voters?

A simple majority vote is required for the proposed budget to be approved, as the proposal meets the acceptable tax levy threshold for West Irondequoit with a 2.83% tax levy increase. The Board of Education could propose one more budget for voter approval, or it could elect to adopt a contingency budget. A contingency budget cannot contain a tax levy that is greater than the levy of the previous year. [B2](#)

## RENEWAL PROJECT UPDATE

Our \$9.6 million Renewal Project, which voters approved last year, is ahead of schedule. The District plans to use the earlier approval to get ahead of the original targeted schedule of Summer 2020. Scheduled for this summer are replacement of:

- K-3 playgrounds at Seneca, Briarwood and Brookview (others will be replaced in 2020).
- Two high-needs roof areas based on current condition: Irondequoit High School Tech wing and Rogers Middle School gymnasium.

# Real Life, Real Learning For Engineering Class

## Students design, produce and install fix for pool

A simple conversation about a recurring issue with the electrical system beneath the starting blocks at Irondequoit High School's pool turned into a terrific educational opportunity for Mr. Dave Marshall's Principles of Engineering class.

The problem: Dirt and water would regularly get into plugs or holes in the Deck Plates for the starting system in each lane, causing it to malfunction during swim meets. So Marshall's 26 students split into six groups. They inspected the Deck Plates in late October and were tasked with designing a cover.

"It was perfect timing, showing our kids how to work as a team, take everyone's ideas and blend them into one. We used the decision matrix to do that," recalled Marshall, a technology teacher who was recently honored for teaching at IHS for 25 years.

The ripple that started the 4½-month project was a conversation between Recreation Supervisor Rachel Schmidt, who handles pool scheduling, and Community Education Director Barb Reardon. Schmidt told Reardon about the touchpad problem and Reardon suggested giving Marshall and his students a shot at fixing it. Each group presented device designs to a panel of adults (Marshall and colleagues) by mid-November, and three groups were chosen to move on to the prototype stage. All three designs were tested at the pool in January and the best one was produced and installed in early March.

The four students on the "winning" team: seniors Abby Levin and Anthony Ha and juniors Taylan Getiren and Chris Marley.

"It helps (us) see that if you want to go (into) the engineering field what you have to go through – all the steps of ideas, all the people's ideas that you have to go through and funnel through for the best ones," said Getiren, who called it fixing a "real world problem."

Ten covers were made; eight for each pool lane and two for the starter system. The design initially had sharp edges, but that was refined so they're smooth. The cover is made of plastic and affixed with superglue and magnets (not hinges). "It's simple but it performs the task," Marshall said. "Now the dirt that used to get in doesn't." Having the design, production and installation of the new covers done in-house, coupled with future savings on repairs/maintenance, should save the West Irondequoit Central School District thousands of dollars.

"It's problem-solving. It's opportunity. It's great," said James Brennan, WICSD's Assistant Superintendent for Finance and a former physics teacher. "Our kids saw the problem and engineered a solution."

It gave them a sense of pride, too. "I can walk into the Irondequoit pool (years from now) and be like, 'I was a part of that,'" said Ha, one of the senior students who'll soon graduate. 🗨️

# The 1:1 Initiative at West Irondequoit

## How laptops in classrooms enhance learning and teaching

A year after it was introduced in West Irondequoit at Dake Junior High School, Iroquois and Rogers middle school students started using 1:1 technology this year. To outfit approximately 800 more students with laptops was a massive undertaking by the District, but done with meaning, purpose and a belief: Computers as a tool for each child helps them become better 21st century learners.

Technology can make learning more engaging for students, and in terms of instruction, can even enhance “collaboration between teachers, students and even other districts,” said Dan Fullerton, who taught Physics at Irondequoit High School for a decade before becoming WICSD’s Director of Technology last fall.

Children are far from intimidated by technology. By the time many reach kindergarten, they’ve experienced iPads and mobile devices.

They also can learn more from each other. Teachers can guide them more swiftly through their own work while also using the work of classmates to display successes and shared shortcomings. “We can give each other positive and negative feedback,” one WICSD middle school student says.

Technology also allows for more personalized learning and differentiated instruction. It’s a more student-centered focus. We know students don’t learn at the same pace or by same methods, so 1:1 technology makes it possible to differentiate the delivery of concepts and assignments, using a variety of methods and tools.




Think about it: If a lesson moves too quickly and some students miss the point, a video can be paused or replayed several times for students who need a little more time. “I feel like it’s easier to learn,” says another WICSD student in grades 4-6.

Take reading, for example. Judy Barrett, a fifth-grade social studies teacher at Rogers, uses a program called “Studies Weekly,” that “allows students to read along as the text is highlighted word by word. It really gives us a lot of flexibility to give students more support.”

“Part of the success with 1:1 has been the willingness of our teachers to take risks and step out of their comfort zones,” says Rogers Principal, Ms. Michelle Flood. “They’re learning and exploring – just like our students – how to improve learning experiences for all students.”

Barrett says it was a little intimidating at first. “Just the thought of shifting lessons and how do you put them in (as) digital content so students can access (them),” she says, noting it also created excitement. “I feel like it was definitely time for us to do this.”

Mr. Christian Zwahlen, the first-year Principal at Iroquois, says the transition has gone well.

“I think that’s because of the buy-in we’ve had from teachers and their willingness and excitement for their own professional development and better learning for students,” Zwahlen said. “It has been really collaborative. Teachers are getting into each other’s classrooms to share and observe best practices.”

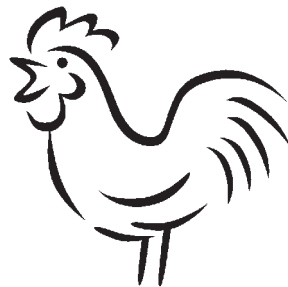

### VOTER QUALIFICATIONS

You are eligible to vote if you are a U.S. citizen; you have lived in the West Irondequoit School District for at least 30 days prior to the vote; you are at least 18 years of age by the day of the vote.

The West Irondequoit Board of Education requires **proof of residency at the polls**. Examples include a driver's license or other documentation proving residence in West Irondequoit. 🗨

### ABSENTEE BALLOTS

West Irondequoit residents, who qualify, can vote on the annual budget and board election by absentee ballot. Residents unable to vote in person because of disabilities, illness, travel or other valid reasons listed under election law, may request an application for an absentee ballot in person weekdays from 8 a.m. to 4 p.m. from District Clerk Patricia Kelly, District Office, 321 List Avenue, Rochester, NY 14617. The application is also available on the district website at [www.westirondequoit.org](http://www.westirondequoit.org). Completed applications must be received in the district clerk's office at least 7 days before the vote (May 14) if ballot is to be mailed, or by 4:30 p.m. the day prior to the vote (May 20) if ballot is to be delivered in person. Absentee ballots must be received by the district clerk no later than 5 p.m. on May 21. 🗨
